

## **NOTICE TO BIDDERS**

Notice is hereby given that the Board of Commissioners of Starke County, will up until 3:30 p.m. central time Monday, November 16, 2009, receive sealed bids for the following items that will be requested by the County Highway Superintendent for the repair and maintenance of County Roads and Bridges.

Bids should be submitted separately, only one proposal on a bid form and only one for each envelope when filed.

All items will be awarded on bids, quality and price.  
Firm bids on items 5, 6, &7.

### **ITEM # 1 BITUMINOUS PATCH MATERIALS**

A. 30,000 tons or less, bituminous patching materials ready mixed as ordered.

#### **WINTER COLD MIX-SUMMER COLD MIX**

All materials and equipment for above bid will meet current INDOT Standard Specifications, state approved source Material certificate required F.O.B. plant.

### **ITEM #2 BITUMINOUS SEAL MATERIAL - NOT APPLIED AS REQUIRED FOR THE YEAR OF 2010.**

1,200,000 GALLONS OR LESS of bituminous materials (delivered to County Highway Department). Delivery shall be made by truck transport as ordered. Delivery of Bituminous materials shall be unloaded into vendor storage tank placed in County Highway Garage lot or placed at a predetermined County Road location as directed by County Highway Superintendent. **Submit bids to: Marshall-Starke Co. Co-op.**

All materials meet INDOT Specifications, except remove stone coating. Bid grades as follows: AE-60, 90, 150, 300, AE-PL Prime coat), RS2 and all grades of Stylink AE-90S.

### **ITEM #3 REGULAR GASOLINE**

2010 QUANTITY 80,000 GALLONS OR LESS

Bidder shall file detailed analysis and octane rating of gasoline bid. Gasoline is to be delivered to Starke County Highway Garage.

#### **ITEM #4 DIESEL**

2010 QUANTITY 90,000 GALLONS OR LESS. Bidder shall file detailed analysis of diesel fuel bid. Diesel fuel to be delivered to Starke County Highway Garage.

#### **ITEM #5 GRAVEL**

2010 QUANTITIES 60,000 CUBIC YARDS OR LESS. Gravel bids will be accepted on pit run and pea stone gravel, and on various sizes screened and washed. Screened gravel in the process of road work as determined by the Superintendent. To be loaded on County Highway Trucks. Bids to be accepted on price per cubic yard or ton.

#### **ITEM #6 CRUSHED STONE**

2010 QUANTITIES 180,000 TONS OR LESS  
Crushed stone to be accepted on number 2, 5, 9, 11, 12, 53, 73, and RipRap. Material shall meet INDOT specifications or equivalent. To be loaded on County Highway Trucks. Bids on a per ton basis. **Submit bids to: Marshall-Starke Co. Co-op.**

#### **ITEM #7 23/24 INDIANA CERTIFIED SAND**

2010 QUANTITIES 100,000 TONS OR LESS  
23/24 Sand to be loaded on County Highway Trucks. Bids on a per ton basis. **Submit bids to: Marshall-Starke Co. Co-op.**

#### **ITEM #8 LIQUID CALCIUM CHLORIDE**

2010 QUANTITIES 80,000 GALLONS OR LESS  
Liquid calcium chloride to be furnished for county roads at the direction of the Highway Superintendent.


#### **ITEM #9 METAL CULVERTS**

5000 FEET OR LESS. **The lapped longitudinal seams shall be factory riveted or secured by an approved spiral winding process.** Corrugated steel culvert pipe. Quote unit prices per lineal foot to include 12" diameter up to 60" diameter. Galvanized steel shall be 2 gauges heavier than aluminized steel pipe to produce equivalent service life. To be delivered as designated within Starke County.

All materials must meet all Federal and Indiana Department of Transportation Specifications. Bidders are to file with their bid certified analysis for the materials they propose to furnish the County.

Each bid shall be accompanied by a bidder bond or certified check in the sum equal to 10% of the bid. Each bidder shall place the number of the item upon which bid is submitted on the outside of the envelope when the bid is filed. All bids must be filed with the County Auditor before 3:30 p.m. central time, Monday, November 16, 2009 Please include two copies.

Bids will be opened and read on Monday, November 16, 2009 at 7:00 p.m. The Board of Commissioners reserves the right to reject any and all bids. Witness my hand and seal of the Board of Commissioners of Starke County, Indiana on this the 12th day of October 2009.
